In August, San Diego Chapter #4 visited U.S. Concrete Precast Division, formerly known as San Diego Precast Concrete Co. The site tour into the plant and yard was conducted by **Todd Ebbert**, General Manager, and assisted by **Gordon Pettis**, Chief Estimator and ASPE member, and **Dennis Wilkes**, Territory Sales Manager for Southern California. Highlights of the tour included seeing how they make their own welded steel molds, experiencing the size and weight of large precast units lifted by a 50-ton bridge crane and rotated as needed with the aid of a separate hydraulic unit weighing 6 tons, viewing the bridge segments for the new Pedestrian Bridge across Lake Hodges, getting a first-hand explanation about the two cement mixers and attached conveying systems for the raw materials (cement, sand, aggregates, admixtures including fly ash), learning about the self-contained, environmentally friendly sandblast booth where all residue is recycled, and finally looking at the specialty precast elements produced by U.S. Concrete Precast. All products are manufactured and cured inside the 80,000 SF plant. At the conclusion of the Site Tour, everybody adjourned to the Boll Weevil restaurant in Imperial Beach. The Chapter bought dinner for all attendees, and **Rex Edmonds** graciously provided the beverages out of his winnings from the Del Mar Racetrack on the previous Saturday's outing (see entry above).
